

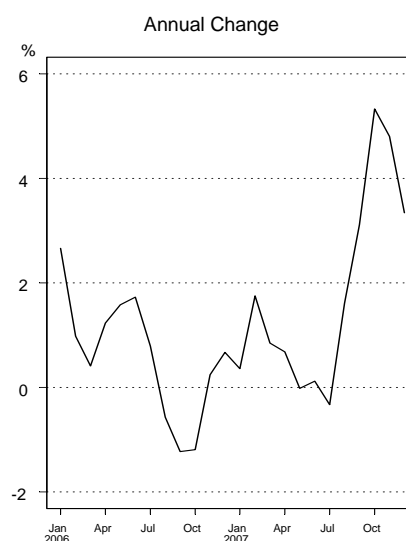
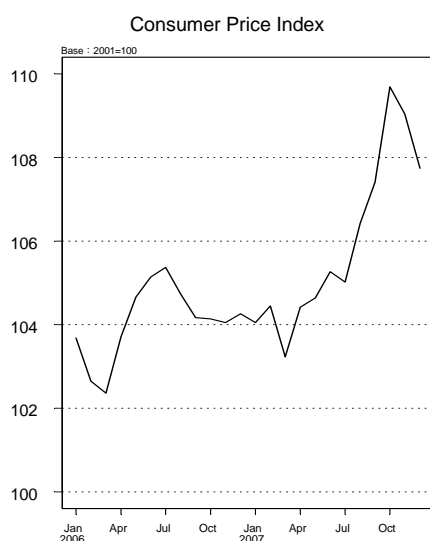
The Price Indices for December 2007

Consumer Price Indices (CPI)

The CPI in December 2007 was 107.74 (2001=100), down 1.19% from last month, due mainly to Vegetables prices declining 29.77%, and Clothing prices down 1.46% , whereas Entertainment Expense and Residential Rent moved up 0.55% and 0.12% respectively. The General Index Excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, went up 0.11%.

The annual change rate for CPI in December 2007 hit 3.34%. Prices of Food increased 7.57%, of which Fruits advanced 20.73%, Eggs up 31.89%, Dairy Products up 13.10%, Meat up 10.05%, Cereals & Cereal Products up 7.09%, Food away from home up 6.74% and Fish & Shellfish up 4.19%. Transportation & Communication prices advanced 3.31%, due mainly to prices of Oils jumped 11.49% and Taxi fees raised 12.13%. Medicines & Medical Care prices went up 4.70%. Some electronic products prices went down continuously. The core CPI in December 2007 compared with the same month of the previous year increased 2.57%.

For the whole year of 2007, the CPI rose 1.80%, where Commodity and Service prices increased 2.71% and 0.70% separately. The core CPI went up 1.35%.

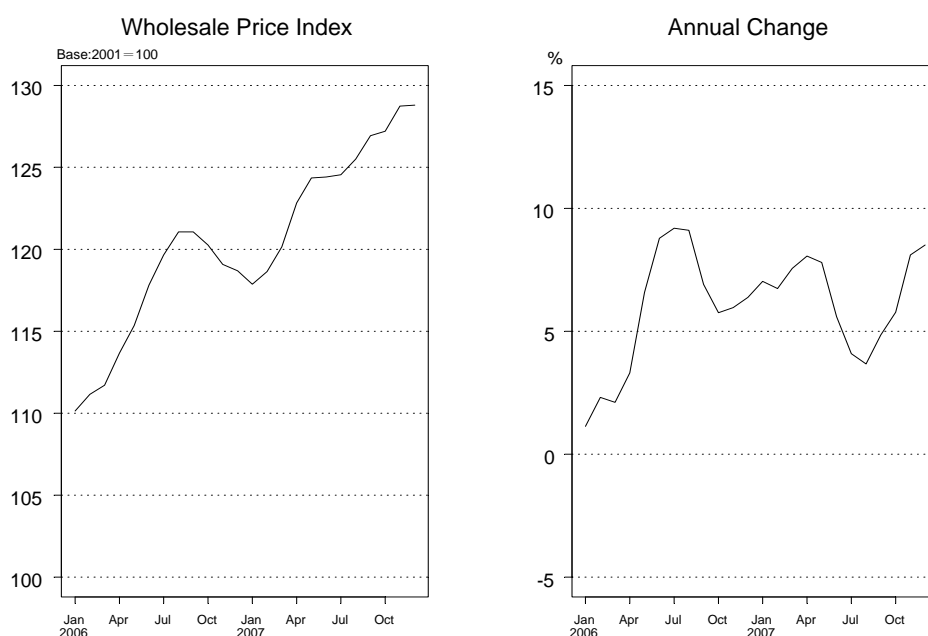


Wholesale Price Indices (WPI)

The WPI in December 2007 was 128.79 (2001=100), advanced 0.05% from last month, due primarily to Petroleum & Coal Products and Chemicals prices increased 1.77%, 1.04% respectively.

The WPI in December 2007 rose 8.51% compared with the same month of previous year, due mainly to prices of Energy Minerals, Petroleum & Coal Products, Chemicals and Primary Metal Products moved up 47.22%, 26.69%, 13.02% and 10.85% individually.

For the whole year of 2007, the WPI increased 6.45% compared with the same period of previous year, of which the Import Price Index and Export Price Index up 8.92% and 3.56% separately.
