
The Price Indices for February 2008

Consumer Price Indices (CPI)

The CPI in February 2008 was 104.26 (2006=100), rose 1.29% from previous month. Due primarily to lack of supply of Vegetables and Fish & Shellfish attacked by cold current, which prices increased 31.99% and 4.77% respectively, meanwhile, Household Keeping Services fees went up 34.45% owing to the annual bonuses being given before the Lunar New Year, whereas Clothing down 4.69% for promotion. The General Index excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, went up 0.93%

The annual change rate for CPI in February 2008 was 3.89%. Prices of Food increased 9.76%, of which Fruits, Meat and Vegetables advanced 20.27%, 11.74% and 9.45% separately, Eggs up 32.68%, Dairy Products up 14.79%, Cereals & Cereal Products up 10.69%, Fish & Shellfish up 7.44%, Food Away from Home up 6.81%. Transportation & Communication prices advanced 4.25%, due mainly to prices of Fuels & Lubricants jumped 16.25% and Taxi fees raised 12.85%. Medicines & Medical Care prices went up 4.92%, due primarily to shortage of Chinese Herbal Medicine which price rose 20.38%. The core CPI moved up 2.65%.

For the first two months of 2008, the CPI moved up 3.42% compared with the same period of previous year, as prices of Commodity and Service rose 5.16% and 1.75% separately. The core CPI went up 2.68%.




Wholesale Price Indices (WPI)

The WPI in February 2008 was 110.34 (2006=100), decreased 0.76% from previous month, due mainly to 2.43% appreciation of Taiwan Dollar to U.S. Dollar. Besides, prices of Computer, Electronic and Optical Products (fell 2.61%), Electronic Parts and Components (fell 2.04%) and Chemical Material (fell 1.27%) went down, while Basic Metal price rose 2.18%.

The WPI in February 2008 increased 8.47% from the same month of previous year, due mainly to prices of Crude Petroleum and Natural Gas, Petroleum & Coal Products, Basic Metal, and Chemical Material advanced 54.84%, 29.53%, 16.10% and 12.67% individually.

For the first two months of 2008, the WPI moved up 9.24% compared with the same period of previous year, of which the Import and Export Price Index rose 15.50% and 1.26% separately.
