

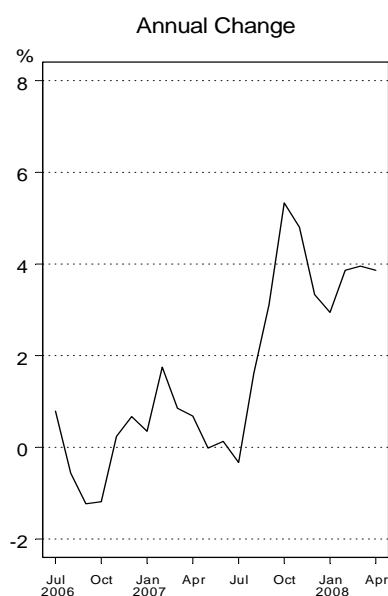
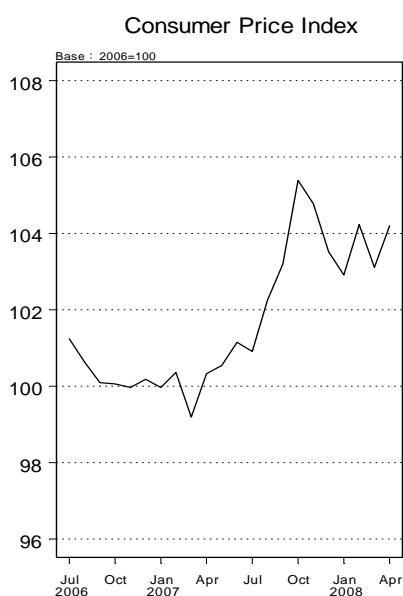
The Price Indices for April 2008

Consumer Price Indices (CPI)

The CPI in April 2008 was 104.20 (2006=100), jumping 1.06% from previous month. Among the major groups and subgroups, price of Clothing went up 12.11% for spring and summer clothes became available, Fruits and Meat prices rose 5.45% and 2.44% respectively, meanwhile, Fuels & Lubricants and Foreign Package Tours fees moved up. The General Index excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, increased 0.95%.

The annual change rate for CPI in April 2008 was 3.86%. Prices of Food increased 9.75%, of which Edible Oil up 36.57%, Fruits up 19.32%, Meat up 15.93%, Dairy Products up 15.48%, Cereals & Cereal Products, Fish & Shellfish and Food Away from Home advanced 12.28%, 10.08% and 9.01% separately, whereas Vegetables fell 11.01%. Transportation & Communication prices rose 3.98%, due mainly to prices of Fuels & Lubricants up 14.92% and Taxi fees raised 12.36%. Housing price went up 1.20%, Education & Entertainment moved up 0.85%. The core CPI rose 3.10%.

For the first four months of 2008, the CPI rose by 3.65% over the same period of previous year, as prices of Commodity and Service rose 5.39% and 1.99% respectively. The core CPI rose 2.86%.

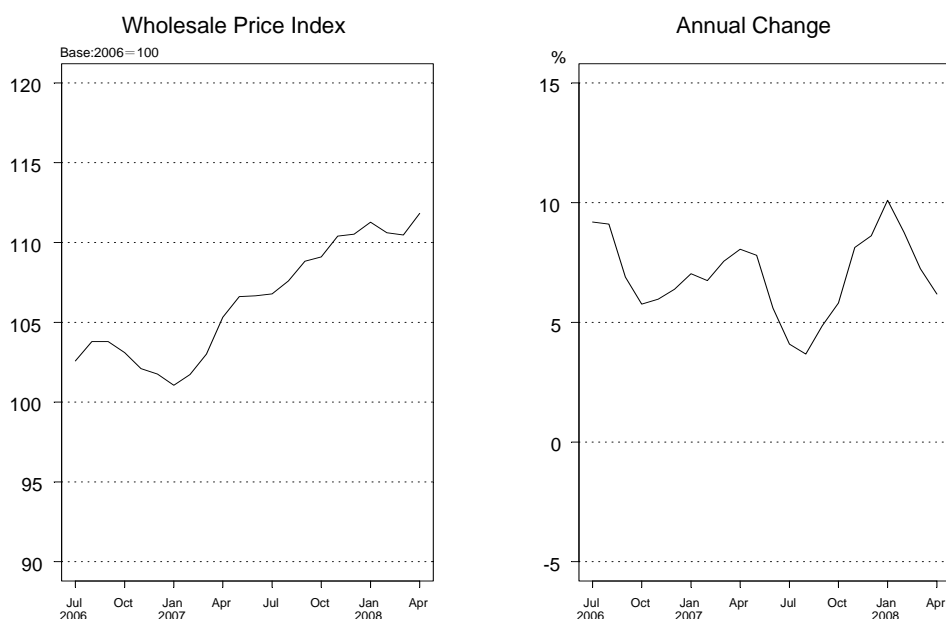


Wholesale Price Indices (WPI)

The WPI in April 2008 was 111.82 (2006=100), increased 1.22% from previous month, due mainly to prices of Quarrying and Minerals Products, Basic Metal, and Petroleum & Coal Products increased 5.92%, 4.99% and 3.75% individually, while Electronic Parts and Components price fell 1.32%.

The WPI in April 2008 increased 6.18% from the same month of previous year, due mainly to prices of Crude Petroleum and Natural Gas, Petroleum & Coal Products and Basic Metal advanced 43.46%, 28.21% and 16.15% separately, whereas Taiwan Dollar to U.S. Dollar appreciated 9.25%. Besides, Domestic Sales Excluding Imports prices up 11.36%, Imports prices up 10.23%, while Exports prices decreased 3.35%.

For the first four months of 2008, the WPI advanced 8.05% compared with the same period of previous year, of which the Import Price Index rose 13.44%, while Export Price Index down 0.75%.
