
The Price Indices for May 2008

Consumer Price Indices (CPI)

The CPI in May 2008 was 104.27 (2006=100), rising 0.08% from previous month. Due primarily to both Fuels & Lubricants and Water, Electricity & Gas Supply prices moved up 0.42%, Prices of Food Away from Home went up 0.55% to reflect increasing costs, and price of Clothing went up 0.84% for spring and summer clothes became available, while Fruits prices declined 9.12%. The General Index excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, increased 0.18%.

The annual change rate for CPI in May 2008 was 3.71%. Prices of Food increased 9.29%, of which Edible Oil up 45.19%, Meat up 18.22%, Dairy Products up 15.33%, Cereals & Cereal Products, Fish & Shellfish and Food Away from Home advanced 12.93%, 12.28% and 9.29% respectively, whereas Vegetables and Fruits decreased 0.92% and 0.72% separately. Transportation & Communication prices rose 3.99%, due mainly to prices of Fuels & Lubricants up 15.03% and Taxi fees raised 12.36%, while part of communication and telecommunication fees went down.

For the first five months of 2008, the CPI rose by 3.66% over the same period of previous year, as prices of Commodity and Service rose 5.35% and 2.06% individually. The core CPI rose 2.94%.



Wholesale Price Indices (WPI)

The WPI in May 2008 was 114.84 (2006=100), jumping 2.62% from previous month, due primarily to prices of Crude Petroleum & Natural Gas, Petroleum & Coal Products, Basic Metal, and Chemical Material increased 14.67%, 6.08%, 3.86% and 2.87% individually, where Domestic Sales Excluding Imports, Imports and Exports prices increased 1.43%, 4.29% and 2.00% separately.

The WPI in May 2008 increased 7.72% from the same month of previous year, due mainly to prices of Crude Petroleum and Natural Gas, Petroleum & Coal Products and Basic Metal advanced 64.39%, 32.21% and 16.96% separately, whereas Taiwan Dollar to U.S. Dollar appreciated 8.75%. Besides, Domestic Sales Excluding Imports prices up 11.33%, Imports prices up 14.02%, while Exports prices decreased 2.56%.

For the first five months of 2008, the WPI advanced 8.00% compared with the same period of previous year, of which the Import Price Index rose 13.62%, while Export Price Index down 1.11%.
