
## The Price Indices for September 2008


## **Consumer Price Indices (CPI)**

The CPI in September 2008 was 106.39 (2006=100), falling 0.60% from previous month, due primarily to Fuels & Lubricants decreased 8.16%, Vegetables and Meat prices moved down 7.67% and 2.35% respectively. Besides, the tour fee became cheaper since the end of summer vacation. The General Index excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, declined 0.13%.

The annual change rate for CPI in September 2008, compared with the same month of previous year, was 3.09%. Prices of Food increased 5.62%, of which Fish & Shellfish up 17.31%, Fruits up 12.97%, Meat up 12.85% and Food Away from Home moved up 6.36%, while Vegetables went down 16.09%. Transportation & Communication prices rose 3.42%, due mainly to prices of Fuels & Lubricants up 10.56%, however, Public Transportation fare and telecommunication fees moved down. The core CPI up 3.25%.

For the first nine months of 2008, the CPI increased by 4.10% over the same period of previous year, as prices of Commodity and Service moved up 6.08% and 2.34% individually. The core CPI up 3.27%.







### Wholesale Price Indices (WPI)

The WPI in September 2008 was 116.06 (2006=100), decreasing 1.42% from previous month, due primarily to prices of Crude Petroleum and Natural Gas moved down 12.13%, Petroleum & Coal Products declined 6.42%, and Basic Metal went down 4.76% individually. Domestic Sales Excluding Imports and Imports prices fell 2.45% and 2.30% separately, while Exports prices increased 0.57%.

The annual change rate for WPI in September 2008 advancing 6.64%, due mainly to prices of Petroleum & Coal Products moved up 28.87%, Crude Petroleum and Natural Gas rose 27.99%, Chemical Material went up 15.44% and Basic Metal advanced 12.97% respectively, whereas Taiwan Dollar to U.S. Dollar appreciated 3.22%. Domestic Sales Excluding Imports prices went up 10.81% and Imports prices moved up 9.99%, while Exports prices decreased 0.89%.

For the first nine months of 2008, the WPI jumped 8.62% compared with the same period of previous year, of which the Import Price Index rose 14.01%, while Export Price Index declined 0.81%.
