
The Price Indices for February 2009


Consumer Price Indices (CPI)

The CPI in February 2009 was 102.86 (2006=100), falling 1.51% from previous month. Due mainly to sufficient supply of Vegetables and Fruits which prices declined 15.87% and 11.26% respectively, and Clothing down 3.80% for promotion. Besides, after Lunar New Year's Day, Price of Household Keeping Services declined 24.40% and Entertainment Expense decreased 5.29%. The General Index excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, went down 1.10%.

The annual change for CPI in February 2009, compared with the same month of previous year, fell 1.31%. Prices of Transportation & Communication prices went down 6.97%, due primarily to prices of Fuels & Lubricants decreased 23.90% and some fees of Public Transportation and Mobile Phone went down for promotion. Prices of Education and Entertainment moved down 2.09% for Entertainment Expense fell 5.13%, compared with the Lunar New Year's prices hike in February of 2008. Housing prices declined 1.05%, where prices of Household Keeping Services went down 25.29%, due to the holiday effect in February of 2008 also. While Food Prices increased 0.79%, of which prices of Meat and Fish & Shellfish went up 6.64% and 6.26% individually.

For the first two months of 2009, the CPI increased by 0.08% over the same period of previous year, as price of Commodity moved down 1.18% and Service went up 1.07%. The core CPI rose 1.46%.







Wholesale Price Indices (WPI)

The WPI in February 2009 was 100.64 (2006=100), increasing 1.29% from previous month, due mainly to 2.91% depreciation of Taiwan Dollar to U.S. Dollar. Prices of Petroleum & Coal Products, Chemical Material and Electronic Parts and Components advanced 4.21%, 3.78% and 2.39% respectively. Domestic Sales Excluding Imports, Imports and Exports prices moved up 0.15%, 1.49% and 2.10% separately.

The annual change of WPI in February 2009, comparing with the same month of 2008, decreasing 9.04%, due mainly to prices of Crude Petroleum and Natural Gas went down 46.79%, Chemical Material and Basic Metal moved down 27.97% and 27.46% individually. Domestic Sales Excluding Imports prices fell 11.04% and Imports and Exports prices went down 10.58% and 5.58% respectively.

For the first two months of 2009, the WPI moved down 9.88% compared with the same period of previous year, of which the Import and Export Price Index declined 11.46% and 7.45% separately.
