

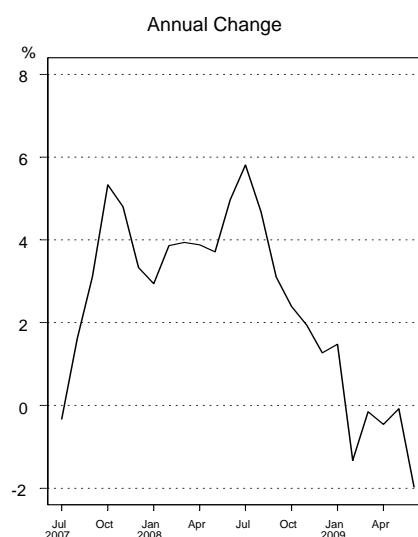
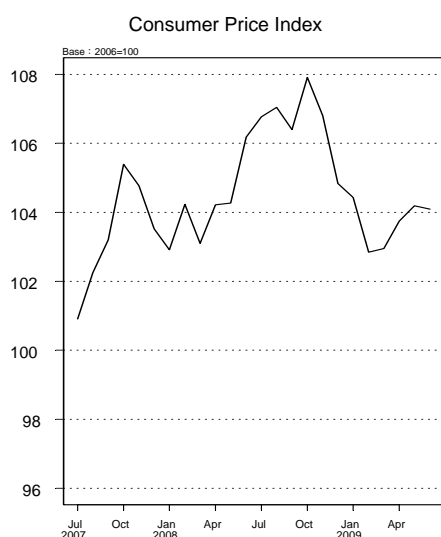
The Price Indices for June 2009

Consumer Price Indices (CPI)

The CPI in June 2009 was 104.09 (2006=100), falling 0.10% from previous month. Due mainly to prices of Fruits and Garments decreasing 12.81% and 4.89% respectively, while Electricity fees went up for beginning to apply summer electricity rates since June. Besides, Fuels & Lubricants increased 6.93%. The General Index excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, declined 0.30%.

The annual change for CPI in June 2009, compared with the same month of previous year, moved down 1.97%. Prices of Transportation & Communication prices went down 6.72%, due primarily to prices of Fuels & Lubricants decreased 19.10%. Prices of Food declined 2.28%, of which prices of Fruits, Vegetables and Meat went down 15.74%, 11.16% and 5.67% separately. Education & Entertainment fees went down 2.09%, due mainly to tour fees for traveling overseas were much lower because of economic recession and H1N1 flu. The core CPI fell 0.61%.

For the first half year of 2009, the CPI decreased by 0.43% over the same period of previous year, as price of Commodity moved down 1.55% and Service went up 0.46%. The core CPI advanced 0.59%.



Wholesale Price Indices (WPI)

The WPI in June 2009 was 101.21 (2006=100), rising 1.52% from previous month, due mainly to prices of Crude Petroleum and Natural Gas went up 18.00%, Petroleum & Coal Products moved up 8.10%, and Water, Electricity & Gas and Basic Metal increased 6.67% and 2.86% respectively. Domestic Sales Excluding Imports, Imports and Exports prices increased 0.71%, 3.37% and 0.47% separately,

The annual change of WPI in June 2009, comparing with the same month of 2008, fell 13.62%, due mainly to prices of Crude Petroleum and Natural Gas went down 40.55%, Basic Metal, Petroleum & Coal Products and Chemical Material moved down 38.88%, 37.00% and 28.36% individually. Domestic Sales Excluding Imports prices fell 15.96% and Imports and Exports prices went down 14.68% and 10.13% respectively.

For the first half year of 2009, the WPI decreased 11.29% compared with the same period of previous year, of which the Import and Export Price Index declined 13.41% and 7.73% separately.
