
The Price Indices for July 2009


Consumer Price Indices (CPI)

The CPI in July 2009 was 104.28 (2006=100), rising 0.19% from previous month. Due mainly to prices of Vegetables increasing 10.96%, Tobacco price went up and Entertainment Expense moving up 3.18% respectively, while Garments price decreased 5.21% for end of summer discount. The General Index excluding Fruits, Vegetables, Fish, Shellfish and Energy, i.e. core CPI, went up 0.01%.

The annual change for CPI in July 2009, compared with the same month of previous year, moved down 2.33%. Prices of Transportation & Communication prices went down 8.18%, due primarily to prices of Fuels & Lubricants decreased 21.30%. Prices of Food declined 2.65%, of which prices of Fruits, Vegetables and Meat went down 15.57%, 8.83% and 6.79% separately. Education & Entertainment fees went down 2.52%, due mainly to tour fees for traveling overseas were much lower because of economic recession and H1N1 flu. The core CPI fell 0.93%.

For the first seven months of 2009, the CPI decreased by 0.71% over the same period of previous year, as price of Commodity moved down 1.93% and Service went up 0.27%. The core CPI advanced 0.37%.







Wholesale Price Indices (WPI)

The WPI in July 2009 was 102.21 (2006=100), rising 1.05% from previous month, due mainly to prices of Basic Metal, Chemical Material and Petroleum & Coal Products went up 4.50%, 3.61% and 3.21% respectively. Domestic Sales Excluding Imports, Imports and Exports prices increased 1.35%, 0.89% and 0.93% separately,

The annual change of WPI in July 2009, comparing with the same month of 2008, fell 14.11%, due mainly to prices of Crude Petroleum and Natural Gas, Petroleum and Coal Products and Basic Metal went down 44.46%, 38.40% and 36.91% individually. Domestic Sales Excluding Imports prices fell 16.58%, Imports and Exports prices went down 15.98% and 9.52% respectively.

For the first seven months of 2009, the WPI decreased 11.75% compared with the same period of previous year, of which the Import and Export Price Index declined 13.93% and 7.97% separately.
